Man, even five hundred years ago, was shorter than he is today. Now, on average, man is about three inches taller. We may assume that man will continue to grow taller. In the modern world we use our brains a great deal. Even so, we still make use of only about 20% of the brain's capacity. As time goes on, we shall have to use our brains more and more-and eventually we will need larger ones! This is likely to bring about a physical change too; the head, in particular the forehead, will grow larger. Besides, our eyes are in constant use. In fact, we use them so much that very often they become weaker and we have to wear glasses. But over a very long period of time it is likely that man's eyes will grow stronger. On the other hand, we tend to make less use of our arms and legs. These, as a result, are likely to grow weaker. Nonetheless, our fingers will grow more sensitive because they are used a great deal in the modern life. But what about hair? This will probably disappear from the body altogether in course of time because it does not serve a useful purpose any longer. In the future, both sexes are likely to be bald! Perhaps all this gives the impression that future man will not be a very attractive creature to look at! This may well be true. However, in spite of all these changes, future man will still have a lot in common with us. He will still be a human being, with thoughts and emotions similar to ours.
